Appeal of the civil society organizations working on the issues of girls, women, children, persons with disabilities, and minorities

To the members of the State Constitutional Commission of Georgia, the Parliament of Georgia, and the Council on Gender Equality at the Parliament of Georgia

We, civil society organizations working on human rights issues, including gender equality and the rights of women, children, persons with disabilities and other minority groups, would like to express our opinion about the work of the State Constitutional Commission of Georgia, which is not oriented at improving the human rights situation of the most vulnerable and oppressed groups. We were once again convinced in the aforementioned by the discussions which followed presentation of a

recommendation, submitted the Georgian Young Lawyers' Association (GYLA), for the development of constitutional safeguards for gender equality at a meeting of the working group of the Commission. Presentation of this recommendations was followed by dismissive and sarcastic remarks on the part of the Commission members.

We believe that the rights of women and other vulnerable groups are not implemented properly, which is mostly caused by a lack of constitutional safeguards of substantive equality. The infringement on the dignity of women and minorities is manifested in the most visible way in the exercise of social, economic, cultural and political rights. For this reason, we believe it is crucial that the protection of vulnerable groups should become grounds for social consensus. The Constitution of Georgia should be the main mechanism for the achievement of substantive gender equality in the country, which will ensure equality of girls, women, persons with disabilities, and minority groups.

In view of all the aforementioned, we call upon:

Members of the State Constitutional Commission:

- To discuss the mechanisms for achieving real (substantive) equality of girls, women, persons with disabilities, and minority groups with an in-depth knowledge of and sensitivity to the issue, with the aim of full involvement of the aforementioned groups in social, economic, political and cultural life and improving their rights situation in general;
- To involve organizations specializing in the issues of girls, women, persons with disabilities, and minorities in the work of the State Constitutional Commission with a relevant status;
- To hold consultations with civil society organizations and groups working on gender equality issues to ensure that the needs of women, girls, persons with disabilities, and minorities will be reflected in the supreme law of Georgia.

• The Parliament of Georgia:

To exercise more care and responsibility in relation to the obligations
